- One passport-sized photograph of the student
- One passport-sized photograph of each parent
- One passport-sized photograph of any authorized guardian (other than parents) who may pick up the child or be contacted in case of emergency
- One copy of each parent's National ID
- For transfer students: A copy of the student's latest academic report
- Medical documents if the student has any medical/special need condition worth mentioning

**Tuition Fees Payment Guideline:**

The tuition fees for **May -June** must be paid together **on/before collecting Admit card**. Similarly, the tuition fees for **November and December** must be paid together **on/before 10th November**. This guideline is applicable to both students who will continue in the next session and those who will discontinue.

Late Payment Policy:

A late payment fee of **BDT 1,000** on tuition fees and **BDT 500** on ECA fees will be charged for every **10 days of delay** beyond the due date.

- **All fees are non-refundable except security deposit.**

Security Deposit:

A refundable security deposit of **BDT 30,000** will be applicable from January 2026.

Withdrawal Procedure:

Parents intending to withdraw their child from the school are requested to provide prior notice via email to the helpdesk at helpdesk@eisdhaka.org

Withdrawal & Refund Policy:

- Withdrawal applications submitted **on or before 30th November** will be refunded by **31st January**. Applications submitted **after 30th November** will be refunded in **June 30th**.
- Withdrawal applications submitted **on or before 30th June** will be refunded by **31st August**. Applications submitted **after 30th June** will be refunded in **January 31st**.

Note: All fees and charges are subject to revision at the discretion of the school management.

Change of Address and Contact Number

Attendance and Punctuality Policy

Attendance and punctuality are vital for a student's success. Regular attendance in the early years lays a strong foundation for academic achievement and social development throughout a child's life. Absenteeism and tardiness can negatively affect both academic progress and social skills.

At EISD, students are expected to meet or exceed our attendance expectation of 95 percent (equivalent to attending at least 4.75 days per week) throughout the academic year. This standard aligns with both national and international guidelines. Students who are not in their classroom at the scheduled start time of the first lesson, will be marked late. Late arrivals will be reported to and dealt by the admission office.

EISD understands and supports legitimate reasons for absenteeism, including illness, injury, cultural or religious observances, and bereavement. In such cases, the school will work with the student and family to provide necessary support.

For absences outside these reasons, a written and signed request from a parent or guardian is required. The Programme Coordinators or authorized delegate will review and decide on the approval of such requests.

Student Code of Conduct on School Premises

All students are expected to uphold the following standards of conduct while on school premises.

Demonstrate Respectful Behaviour

Students shall treat all teachers, staff, peers, and visitors with courtesy, respect, and professionalism. Disrespectful, abusive, or insubordinate behaviour will not be tolerated.

Promote a Safe and Inclusive Environment

Contribute to an environment that is safe, welcoming, and free from discrimination, harassment, bullying, or intimidation. Any act of bullying, harassment, intimidation, fighting, or any form of misconduct that compromises the safety or well-being of others will result into disciplinary actions.

Regularity and Punctuality

Students are expected to maintain regular attendance, arrive on time for school and lessons, and fulfil all academic commitments. Failure to comply with this policy may result in the issuance of a Letter of Concern, followed by a meeting with the student's parent(s) or guardian(s), where appropriate.

Maintain Personal and Campus Cleanliness

Students must wear their ID cards and attend school in proper clean uniforms. Students are also expected to keep classrooms and all school premises clean by disposing of waste responsibly and maintaining an orderly environment.

Contribute to a Positive Learning Environment

Students must refrain from disrupting lessons or engaging in behaviour that interferes with teaching, learning, or the rights of others.

Respect School Property and Learning Resources

Students shall handle school facilities, furniture, equipment, textbooks, exercise books, laboratory materials, and other learning resources with care and responsibility. Deliberate damage of any such items may result into disciplinary actions.

Observe Safe Movement around the Campus

Running, pushing, rushing, or engaging in unsafe behaviour in corridors, staircases, or other shared spaces are prohibited to ensure the safety of all members of the school community.

Refrain from carrying prohibited items to School

Students must not carry any illegal items, hazardous materials, or any other items prohibited by the school will result into disciplinary action.

Comply with Safety, Security and Emergency Procedures

Students must follow all instructions issued by school authority during drills, emergencies, evacuations, or lockdown procedures.

Students are expected to comply with all security measures, including entry and exit procedures, identification checks, and visitor protocols established by the school authority.

Accept Responsibility for Personal Conduct

Students are accountable for their actions and are expected to comply with all school rules, policies, and directions issued by the authority.

Prohibited and Dangerous Items

Students must not bring to school any item that could pose a danger to themselves or others. This includes, but is not limited to, knives, imitation weapons, or any other potentially harmful objects.

Electronic devices such as mobile phones, music players, or handheld gaming consoles are also not permitted for recreational use during school hours. If brought for legitimate purposes, such items must be kept securely in school bags and used only when authorized by a teacher for educational activities.

Please note: The school will not be held responsible for the loss of or damage to any valuable electronic equipment brought to campus.

Consequences of Misconduct

Breach of this Code of Conduct may result in disciplinary action being taken, in accordance with the school's Positive Behaviour and Wellbeing Policies.

Segregation

Emerald promotes modesty in interactions between genders and fosters an environment of mutual respect and dignity for all students.

From Grade 3 onwards, boys and girls will be seated and engaged in activities separately, in alignment with the school's Islamic ethos promoting modesty and appropriate interaction between students. This arrangement is implemented with care, without hindering learning progression or assessment in any way, and without compromising the quality of teaching and learning.

General & Disciplinary Rules & Regulations

Drop-Offs and Pick-Ups

It is important that students arrive on time so classes can begin smoothly. Please refer to the "Guidelines for parents" section in the diary for your child(ren)'s designated drop-off and dismissal times.

Late Arrivals

If you are dropping off your child after classes have started, please accompany them to the Admissions Office. They will be marked present (but late) and escorted to class by a Child Care Assistant (CCA). Students who arrive after 8:05 AM (excluding early years) will be officially recorded as tardy. On the third day of being late will result in sending the child back home.

Early Leave

If a student needs to leave school early, parents should send a note via email or the parents' portal (ERP) to the Homeroom teacher in advance. In case of emergencies, it can be managed by calling the helpdesk number, based on the discretion of the authority.

Late Pick-ups

In case of any parent running late for pick-up, he/she must inform the admissions office (helpdesk number) directly.

Early Dismissals

Students may be sent home early in the event of emergencies such as extended power outages that cannot be resolved with generator backup. In such cases, parents will be contacted over the phone by school admin and asked to collect their child.

Absences

If your child is absent for a day or more, please notify the Homeroom teacher through email, phone call or the parents' portal (ERP) beforehand. For extended absences, email the Homeroom teacher with your child's name, class, reason for absence, and expected duration. If the absence extends beyond two days, a medical certificate must be submitted to the Admissions office or sent to the Homeroom teacher via email.

In the event of a prolonged student absence, parents who wish to collect the student's books and notebooks must clearly state this request in the written application or email and obtain formal approval from the school administration. Any absence on the days of a scheduled classwork or test will be considered only upon submission of application. Under such circumstances the student will be allowed to sit for a make-up test on the first day they resume class.

Families are kindly requested to plan travel according to the school's academic calendar. Appointments with doctors or dentists should ideally be scheduled after school hours or during breaks.

Authorized Pick-Up

Students may only be picked up by parents, guardians, or others specifically authorized by the family.

ID Cards for Students, Parents, and Guardians

- ID cards are required for identification and pick-up purposes.
- All parents must submit two hard copies of recent passport-size photographs for the student, each parent, and any authorized guardians.
- ID cards can be ordered from the Admissions Office for BDT 500 each.
- Please collect your ID cards from the Admissions Office.

Snack / Lunch Break & Drinks

Students may bring their own lunch and drinking water from home. We strongly encourage nutritious meals that include fruits and/or vegetables to support healthy growth and learning.

To make eating easier and reduce mess, we recommend that children bring finger foods when possible. All students should carry a refillable water bottle; safe, filtered drinking water is available on campus. Store bought chips and candies are discouraged as they contain unhealthy amount of sugar or salts and artificial flavorings.

Lunch boxes should be compact and clearly labeled with the student's name and class. For students bringing hot meals, we recommend using a thermos to keep food warm.

Dress Code

Uniform: Preschool – Grade 8

At EISD, wearing the school uniform is required for all students. We believe that a consistent dress code fosters a sense of belonging, pride, and equality among students. Please ensure your child is dressed appropriately for the season. For example, they should carry raincoats during the monsoon and dress warmly (following the color code approved by school authority) during colder months.

- Students are required to wear clean, neatly ironed uniforms with white socks and white sneakers and demonstrate decency, dignity, and modesty in both their appearance and behavior at school.

- From Nursery onward, all students at EISD are required to wear the official PE uniform on designated class days. No shirt/t-shirt of other colors will be allowed, as uniform. To maintain consistency and ensure quality, the uniform must be purchased from the school's designated vendor. Please refer to the diary's 'Uniform' page for a clear understanding.
- Girls' hair should be tied back neatly and kept away from the face and boys should comb their hair to present themselves as neat and tidy. Hair clips, rubber-bands and other accessories for the hair must be of white or black color only.
- For female students of Grade 2 onwards, wearing a hijab and covering the hair is included as part of the school curriculum. The Hijab must be worn in accordance with Islamic guidelines for modesty so it should be properly draped, not styled or fashioned, shortened, or clipped to the side in any manner.
- Students are required to wear proper hijab, uniform, and shoes at all times. Fancy shoes, decorative watches, or variations of the prescribed hijab are not permitted. Failure to comply with these guidelines for three consecutive days will result in the student being sent home.
- Make-up is not permitted at any time. The use of any kind of makeup or nail polish is strictly prohibited.

Cleanliness and Personal Hygiene

Good personal hygiene and cleanliness are part of the school's values. EISD nurtures students to become confident, self-aware individuals who take pride in their appearance and overall presentation.

- Students are expected to maintain fresh, clean skin and ensure they are free from any unpleasant body and mouth odor at all times. Before coming to school every day, they must wash their faces, brush their teeth, use deodorants, wear clean socks and sun-dried clean shoes (regularly washed and dried in the open air specially under the sun, to avoid spreading bad odors) to keep them safe from any unhygienic conditions. Students are also encouraged to carry perfume or Attar to promote the healthy practice of being presentable all the time.
- All parents must ensure that students' nails are kept trimmed regularly and that boys' hair is neatly trimmed and well groomed.
- If you discover that your child has head lice, please inform the school promptly. This allows us to remind all families to regularly check and treat effectively. If this practice is followed school-wide, heavy or recurrent lice infestations can be prevented. Parents or caregivers will be notified immediately if head lice are detected on their child at school. While children with head lice are generally not sent home, persistent or recurrent cases will be addressed individually. In such cases, the school authority may decide to send a child home until treatment has been effectively completed.

At Emerald International School Dhaka, we promote healthy lifestyles that value the physical and emotional well-being of everyone in our school community. When addressing issues related to this, we recognize the importance of collaboration among all families.

Independent self-management skills

We encourage independence in all aspects of student life. Teachers will guide and train students to carry out these routines independently at school; however, parents are expected to reinforce the same practices at home to ensure consistency and to help students develop full independence.

- From Nursery onward, students are expected to be able to move, eat and drink independently.
- From Kindergarten onward, students should be able to dress and clean themselves after using restroom without assistance.

Materials and Supplies

Students should bring only the essentials to school in a small backpack. These include:

- A snack/lunch box
- A refillable water bottle
- A handkerchief
- An extra set of clothes for students of Early Years (PG-KG 2) inside a packet with the student's name written on it
- 1–2 diapers (for PG and Nursery students who are not yet potty-trained)
- A raincoat during the rainy season
- Any prescribed medication (to be clearly labelled and handed to the Homeroom teacher)

As part of the Curriculum Support Fee, all students will receive their books, notebooks, and stationery from the school. These materials will be issued, stored, and cared for by the Homeroom Teachers in the classroom.

Please ensure that all items sent from home are clearly labelled with your child's name and class.

Valuables

Students are strongly discouraged from bringing cash or valuables to school. If a student must bring a valuable item for a specific school-related activity or project, it should be handed over to the Homeroom Teacher for safekeeping upon arrival.

Please note that the school cannot be held responsible for any loss, damage, or theft of personal valuables brought onto campus.

The parents' portal (ERP): Our Digital Student Diary and Parent Communication Tool

The parents' portal (ERP) is a secure digital platform used at Emerald to enhance communication between home and school. It allows students to share their learning and progress, while parents stay informed and involved in their child's day-to-day experiences.

Each student has a profile where photos, drawings, and notes of their work are uploaded. Parents can view these updates in real-time and receive important notices from teachers or school staff directly through the app.

We encourage all parents to download the parents' portal (ERP) app and activate their account using the link or code provided by the admission office. It's one of the best ways to remain engaged with your child's school life and celebrate their growth.

If you have any trouble accessing the parents' portal (ERP) or need assistance, please feel free to contact the Admissions Office or your child's Homeroom Teacher.

Information Technology (IT) and Digital Learning at Emerald International School Dhaka

At Emerald International School Dhaka, we strive to promote the responsible and appropriate use of digital technologies while fostering attitudes and behaviors that protect our students, the broader school community, and our IT resources. Our IT Policy is divided into two key parts:

Acceptable Use of IT at Emerald International School Dhaka

This section outlines the specific agreements regarding the use of the school's IT systems and digital resources.

Guidelines for the Use of Digital Technologies

This provides general advice on using all digital technologies—including social media—both within and beyond the school environment.

Technologies and resources covered under this policy include, but are not limited to:

- Shared classroom technology
- Local and wireless network resources
- Cloud-based systems and tools provided by the school
- Use of external digital platforms
- Data protection and security
- Privacy and e-safety

All students and parents are required to review the Acceptable Use Policy for Information Technology at Emerald International School Dhaka. We encourage parents to discuss the policy with their children to ensure clear understanding and shared responsibility.

Acceptable Use of ICT

Emerald International School Dhaka is committed to supporting students' learning and use of ICT across all grade levels and disciplines in the school's languages of instruction.

Acceptable use of computers, related devices, networks, and internet access must always align with the educational objectives of Emerald International School Dhaka.

All communications and use of computers, networks, network equipment, and Internet access are privileges granted to students, not rights. We expect students to use these tools responsibly for educational purposes and to show consideration for all other users.

1. Student personal information (including but not limited to names, phone numbers, addresses, etc.) must not be entered, transmitted, or posted over the Internet for public use without prior authorization from school administration.
2. Students will be taught the safe use of ICT and digital etiquette (Netiquette), with appropriate supervision to ensure these practices are followed.
3. Students must not use the network or the Internet in ways that disrupt access for others, such as downloading large files, sending mass emails, or harassing other users. The privacy of all users must be respected, as all communications and information are the property of Emerald International School Dhaka.
4. It is unacceptable to intentionally damage or destroy hardware or data belonging to others, whether within the school or on any site connected to the Internet. This includes creating or spreading computer viruses, Trojans, or other malicious threats.
5. Through technology, we aim to provide opportunities for students to develop skills required in this 21st Century investigating, creating, communicating, collaborating, and organizing — all while becoming responsible digital citizens.
6. On the occasions where students need to use the school computers and laptops, the internet will be provided by the school.
7. Any kind of cellular device will not be allowed for students in the school campus.
8. While working, students are not allowed to print any file directly using printer, they will send the file to teacher or IT team to print the file for them.

Shared Classroom Technology

Emerald International School Dhaka provides a wide range of classroom technology resources, including laptops, workstations and specialist hardware to support all subjects in our Cambridge curriculum. Students are expected to treat these resources with care and respect. Any damage to equipment will be reported promptly to the Homeroom teacher and the parents.

Students must not change physical connections or alter the configuration of classroom technology without the express permission of the ICT teacher. When such changes are made, it must be understood clearly that settings will be restored to their original state after use.

Under no circumstances should any student install or attempt to install software, or change any security permissions on any device.

Cloud-Based Systems and Resources

Emerald International School Dhaka provides a broad and continually evolving collection of online systems and resources, many of which require users to log in with personal account names and passwords.

Such account details must be carefully protected and should never be shared with anyone except teachers and parents. It is crucial to ensure you are properly logged out from any secure system accessed through a shared device.

If you discover that another user has left a personal account open, please close the account immediately or inform a teacher or the IT support team.

Sending an inappropriate message from another user's email account is considered a serious breach of the IT policy.

Students should:

1. Respect the minimum age limits for accessing social network sites (usually 13 years old).
2. Not intentionally access, transmit, copy, or create material considered inappropriate. This includes but is not limited to pornographic, threatening, rude, discriminatory, or harassing messages or materials.
3. Respect and protect the intellectual property of others and not infringe upon copyright or intellectual property rights. This includes refraining from making or distributing illegal copies of music, games, or movies.
4. Not use the school's resources to further any criminal acts.
5. Not use the resources to send spam, chain letters, or other unsolicited mass mailings.
6. Not buy, sell, advertise, or conduct business through school IT resources unless approved as a school project.
7. Avoid plagiarism by giving full acknowledgment of sources for any materials or ideas submitted as coursework or assignments.

Data Protection and Security

Students should:

1. Use only assigned accounts to access Emerald International School Dhaka's systems and resources.
2. Not attempt to view, use, or copy passwords, data, or networks to which they are not authorized.
3. Never attempt to install unauthorized software.
4. Not delete, edit, or move data or other resources that do not belong to them.
5. Respect and protect the privacy of others by not posting or distributing private information about others or themselves online or elsewhere.
6. Report immediately to a teacher any incident that causes them to feel threatened or uncomfortable.

Supervision and Monitoring of IT Resources

School and network administrators monitor IT resource usage to ensure security and compliance with the school's mission. The school reserves the right to examine, use, and disclose any data found on its

networks or information systems to maintain the health, safety, discipline, or security of any student or other person, or to protect property.

User accounts and internet access may be monitored, and logs of inappropriate activities maintained. Students are encouraged to use the school's IT resources thoughtfully and responsibly.

Consequences

Consequences will be implemented if the agreements outlined in this policy are not followed.

Guidelines for Use of Digital Technologies:

Classroom Use of Social Media

Students are expected to refrain from accessing social networking sites during school hours unless explicitly directed to do so as part of a class activity. Teachers must limit class activities to approved online tools.

Contributions to Wikis, Blogs, and Online Forums

When posting messages to Emerald International School Dhaka's forums or blogs, students should observe appropriate etiquette and avoid posts or responses that could be misinterpreted or cause offense.

Social Networking Sites

Many social networking sites have minimum age requirements for membership. Students who have not reached the permitted age are strictly prohibited from creating or using accounts on any social networking site while on school premises or using the school's network.

Privacy Settings

Most social networking sites offer privacy settings that can be adjusted to limit search ability and access to profiles. Students should use these settings prudently, consistent with the requirements of this policy, to protect their online privacy.

Use of EISD Email Accounts

Messages sent from EISD email addresses (such as it@eisdhaka.org) should always reflect professionalism and uphold the values and reputation of Emerald International School Dhaka. Content must be courteous, respectful, and appropriate for a school setting.

Data Protection

To help ensure digital security, all users should protect their network accounts with a strong, private password. Never share your password with others. If there is any suspicion that your account may have been accessed by someone else, or if your password has been shared, please change it immediately and notify the appropriate school personnel if needed.

E-safety

All students—and their parents—are encouraged to be aware of the potential risks associated with using digital technologies. As part of our commitment to digital well-being, Emerald International

School Dhaka emphasizes the importance of understanding these risks and adopting safe, responsible habits when using online tools.

We encourage families to maintain open communication about online activity and to work together to establish clear guidelines and strategies that help protect children in the digital world.

Personal Information

It is essential for the school to have complete and up-to-date information about all students and their emergency contacts. Please ensure the school is informed of any changes or additions to the following details by sending an email to helpdesk@eisdhaka.org

For health and safety reasons, parents should notify the school of any changes related to:

- Home address or telephone number
- Parents' and other contact details, especially mobile phone numbers and email addresses
- Medical information, allergies, operations, vaccinations and any other relevant health matters.

Medical Information and Attention

Parents should inform the Homeroom teacher through the school admin of any special health information like:

- allergies, short- or long-term health problems, medical history or any medical conditions
- any contagious illness such as measles, mumps, scarlet fever, and chickenpox.
- conditions like lice and ringworm
- requirement of specific medication during the school day accompanied by a valid prescription

If a student becomes unwell while at school, they must go or be taken to the Admissions Office. A nominated staff member, either the Homeroom/subject teacher or an administrative assistant (who are trained First Aiders) will assess the student's condition and decide whether the student should be sent home. The school will notify the student's parents to arrange for pick-up.

For minor complaints, only the Homeroom teacher is authorized to administer medication based on parents' acknowledgement. In cases of more serious concerns, the school will contact the parents directly. In emergencies, the school will contact parents and follow the doctor's recommendations for

medical care, including surgical intervention if necessary. Therefore, it is vital that the school has up-to-date contact details, including telephone numbers and addresses. Please notify the Admissions Office immediately of any changes to your contact information.

Parents will be systematically informed whenever the school contacts them regarding their child's health; however, immediate communication may not always be possible. A Student Incident Report is completed whenever a student is injured and communicated to the parent on that day.

Consent Forms

Throughout the year, the school will send out parental consent forms for various activities. These forms must be signed by a parent or legal guardian before a student is permitted to participate in the designated activity.

Parental Absence

Please notify the Homeroom Teacher and the Admissions Office if you plan to be out of town for more than one day. The school requires details of appointed guardians and emergency contact numbers for pick-ups during your absence.

School Closure

If it becomes necessary to close the school at short notice, such as due to extreme weather conditions, the school will notify all parents via email and/or SMS. If you have any concerns, please check your email first before contacting the school Office.

Library

Every classroom at EISD features a reading corner to encourage a love of reading among students. Our class room library offers a wide range of age-appropriate books, providing students with materials both for pleasure reading and for classroom research across various subjects.

24 hours CCTV Surveillance

The entire school is under 24hrs surveillance inside-out. There are day and night guards on the watch at all times.

Visitors of EISD

All visitors to the campus are required to report to the main gate security guard at the school gate, where their identity will be checked with the reception desk and his/her name, time of arrival will be noted before entering the school premises. They will then be handed over a Visitor's Badge/ID Card and then directed to the admission office area where they will need to inform his purpose of visit. The badge/ID needs to be displayed at all times. Visitors may need to wait unless they have a prior appointment.

Grade Level Coordinators and Homeroom Teachers

At EISD, each student has a Homeroom teacher who monitors the students' wellbeing, provides a range of general support strategies for everyday concerns (academic or personal/social), and mediates issues.

- Allow others their privacy
- Respect the diverse learning styles of their peers
- Report any perceived bullying or welfare concerns

Parents and Guardians have the right to:

- Have their child's full potential realized within the limitations of available resources
- Meet with staff to discuss school policies, their child's progress, and reports
- Have their opinions valued by the school community
- Be welcomed and respected within the school environment

Parents and Guardians have the responsibility to:

- Show respect towards staff, students, and the wider community
- Model appropriate behavior and language for their children
- Be available and engaged in discussions about their child's progress
- Ensure their child is prepared and supported to follow school policies and participate fully
- Support school programs and initiatives
- Express themselves in a socially acceptable manner
- Respect the privacy and learning styles of others

Health and Safety

If a student's wellbeing is deemed to be at immediate risk, the school will promptly notify the parents. Should the Wellbeing Team determine that a student is unfit to attend school or any school event (such as a field trip), parents may be asked to take the student home.

Please note that the school reserves the right to search students and their belongings at any time during the school day to ensure the safety and wellbeing of the entire school community.

Parental Agreement, Consent, and Acknowledgement

Emerald International School Dhaka requires families to acknowledge that they have read, understood, and agreed to abide by the information contained in the Emerald International School Dhaka Student-Parent Handbook. Prior parental consent is also required for certain activities during the school day (such as short, local field trips) and to safeguard student wellbeing, including administering medical attention.

This section summarizes the necessary parental agreements with the school and outlines consent requirements. Please read the following carefully.

The school will request an electronic acknowledgement confirming that you have read, understood, and agreed to abide by all the regulations and procedures set forth in the Student-Parent Handbook.

In particular, this acknowledgement means that you, the parent or guardian:

- Agree that, under the supervision of their class teacher and/or other school-appointed chaperones, your child(ren) may be taken off campus for field trips during normal school hours. The school will provide prior notification for trips lasting longer than a class period (one hour). For any trips occurring outside school hours, such as overnight trips, the school will seek prior written consent.
- Have read, understood, and agreed to the medical procedures outlined in this handbook; have provided the school with a full and accurate disclosure of your child(ren)'s medical history; and give permission for:

If a student becomes ill or sustains an injury while at school, the student's parent(s) or guardian(s) will be contacted immediately. If they cannot be reached, the school authorities will take responsibility for arranging appropriate medical care and, if necessary, escort the student to a doctor or medical facility.

- Agree to reimburse the school for any medical expenses incurred on behalf of your child.
- Have read and agreed to abide by the Acceptable Use Policy for Information Technology at Emerald International School Dhaka. You may simplify the IT policy and guidelines for younger students and provide consent on their behalf if necessary.
